GRADUATES UNAVAILABLE FOR EMPLOYMENT- the graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.

GRADUATES EMPLOYED IN THE FIELD – graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.

PLACEMENT RATE EMPLOYED IN THE FIELD – is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.

NUMBER OF GRADUATES TAKING EXAM – the number of students who took the first available exam in the reported calendar year.

FIRST AVAILABLE EXAM DATE – the date for the first available exam after the students completed the program.

PASSAGE RATE – the number of students who passed the exam divided by the number of graduates who took the reported licensing exam.

NUMBER WHO PASSED FIRST AVAILABLE EXAM – the number of students who took and passed the first available licensing exam after completing the program.

SALARY – as reported by graduate or the graduate's employer.

NO SALARY INFORMATION REPORTED – the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.

STUDENT'S RIGHT TO CANCEL

- 1) A student has the right to cancel his or her agreement for a course of instruction, without any penalty or obligations, through attendance at the first class session, or the seventh day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro rata refund if you have completed sixty (60) percent or less of the course.
- 2) Cancellation may occur when the student provides a written notice of cancellation at the following address: Covered 6 Security Academy, 868 Patriot Drive, Unit C, Moorpark, CA 93021. This can be done by mail or by hand delivery.
- 3) The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
- 4) The written notice of cancellation need not take any particular form, and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the *Enrollment Agreement*.
